The Board of Directors of AMB Property Corporation(R) today declared a regular cash dividend for the quarter ending December 31, 2006 of \$0.46 per common share. The dividend will be payable on January 5, 2007 to common stockholders of record at the close of business on December 22, 2006.

The Board also declared a dividend of \$0.40625 per share on the company's 6.5% Series L Cumulative Redeemable Preferred Stock for the period commencing on and including October 15, 2006 and ending on and including January 14, 2007. The dividend will be payable on January 16, 2007 to Series L stockholders of record at the close of business on January 5, 2007.

The Board further declared a dividend of \$0.421875 per share on the company's 6.75% Series M Cumulative Redeemable Preferred Stock for the period commencing on and including October 15, 2006 and ending on and including January 14, 2007. The dividend will be payable on January 16, 2007 to Series M stockholders of record at the close of business on January 5, 2007.

The Board further declared a dividend of \$0.4375 per share on the company's 7.0% Series O Cumulative Redeemable Preferred Stock for the period commencing on and including October 15, 2006 and ending on and including January 14, 2007. The dividend will be payable on January 16, 2007 to Series O stockholders of record at the close of business on January 5, 2007.

The Board further declared a dividend of \$0.6802431 per share on the company's 6.85% Series P Cumulative Redeemable Preferred Stock for the period commencing on and including August 25, 2006 and ending on and including January 14, 2007. The dividend will be payable on January 16, 2007 to Series P stockholders of record at the close of business on January 5, 2007.
