The Board further declared a dividend of \$0.4375 per share on the company's 7.0% Series O Cumulative Redeemable Preferred Stock for the period commencing on and including October 15, 2009 and ending on and including January 14, 2010. The dividend will be payable on January 15, 2010 to Series O stockholders of record at the close of business on January 5, 2010.

The Board further declared a dividend of \$0.428125 per share on the company's 6.85% Series P Cumulative Redeemable Preferred Stock for the period commencing on and including October 15, 2009 and ending on and including January 14, 2010. The dividend will be payable on January 15, 2010 to Series P stockholders of record at the close of business on January 5, 2010.
