AMB Property Corporation® , a leading owner, operator and developer of global industrial real estate, today announced that it has signed two leases totaling approximately 127,700 square feet in its AMB Franklin Commerce Center. These two leases bring the 366,900 square foot development to 100 percent leased.

"We welcome these customers to our Class A facility. These new leases are representative of the strengthening economic recovery we are seeing in many of our port markets like New Jersey, which is also a key distribution hub in the U.S.," said Jay Cornforth, managing director, East Region.

The facility is in an established business park that can be accessed from Exit 12 on Interstate 287, a major highway that also serves as a partial beltway around New York City. In addition, the facility is 12 miles west of Exit 10 on the New Jersey Turnpike.

As of March 31, 2010, AMB's portfolio in Northern New Jersey/New York, which includes Eastern Pennsylvania, totaled approximately 13.1 million square feet of operating and development facilities.
