AMB Property Corporation® , a leading owner, operator and developer of global industrial real estate, today announced that it has signed a lease for approximately 128,400 square feet in the AMB I-81 Distribution Center, fully stabilizing the 350,400 square foot development in Harrisburg, Pennsylvania. Alacer Corp., an industry leader in dietary supplements and nutritionally enhanced products, will use the space to expand its East Coast operations.

"We are pleased to welcome Alacer to this state-of-the art facility," said Gene Reilly, AMB's president, Americas. "They were looking for a very specific real estate requirement and we had the ideal solution. This facility puts them closer to their customer base by providing greater access to all of the major East Coast cities."

AMB I-81 Distribution Center is less than one mile from Interstate 81 and approximately five miles from Interstate 76 (the Pennsylvania Turnpike), which connects with Interstate 80 to the west and with the New Jersey Turnpike to the east. This location allows suppliers to move goods throughout the Mid-Atlantic and upper Mid-West in less than a day's drive.

As of March 31, 2010, AMB's portfolio in Northern New Jersey/New York, which includes Eastern Pennsylvania, totaled approximately 13.1 million square feet of operating and development facilities.
